### Important Information

**MIA vROOM:** Agents can participate in our live, interactive CPD seminars through the MIA's online meeting room regardless of their location. **LOCATION:** Agents must nominate a location when booking. Our vRoom has been expanded to 50 seats to accommodate growing interest. Priority will be given to members in regional and offshore locations and those with circumstances that inhibit their access to traditional seminars. Members who prefer to attend a set venue can do so in Canberra and Cairns.

**FORMAT:** All of the activities are one CPD point each. The lecture-style activities are pitched at all levels of agent expertise and are designed to provide agents with the most up to date legislation and case notes. These seminars also allow ample time for questions and scenario discussion. The advanced issues activities are designed for more experienced agents and involve more discussion-style activities.

**MARA UPDATE:** The MARA no longer requires CPD providers to supply certificates to participants, as agents no longer require this proof of completion for the registration process. Confirmation of attendance and acknowledgment of points accumulated are sent electronically to the MARA. In the interests of providing an environmentally friendly organisation, the MIA will not be issuing certificates unless requested by agents at the seminar. These will then be sent by post when the seminar is processed administratively.

### What does it cost?

**REGISTRATION FEE:** The cost of registering per subject is \$55.00 for MIA Members and \$90.00 for Non-members. Payment can be made by credit card (Visa and Mastercard ONLY), cheque or money order.

**DISCOUNT:** There is a 10% discount when registering for 10 or more CPD points on one form. Please fill in the discounted amount in the appropriate section on the registration form.

**ADMINISTRATION FEE:** There is a \$10.00 administration fee per form, which will be waived if the registration form is received at least three working days prior to the first activity registered for.

**CANCELLATION POLICY:** If the MIA is notified in writing of a cancellation of registration for an activity at least five working days before the activity takes place, a pro-rata credit note or refund can be issued. Credit notes can be used to pay for any future MIA CPD activity or conference.
